

RESOLUTION. R19-18

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO PURCHASE
TRASH AND RECYCLING TOTERS FROM BEST EQUIPMENT

BE IT RESOLVED by the Legislative Authority of the Village of Covington, State of Ohio,
that:

SECTION 1: The Village of Covington deems it appropriate and necessary to purchase
100 additional trash and 200 additional recycling toters to assist in the collection of trash
and recycling within the Village;

SECTION 2: Whereas, Best Equipment has provided a quote attached as Exhibit A in
the amount of \$17,593.54 to provide the necessary trash and recycling toters to the
village;

SECTION 3: Whereas, the Village of Covington finds the purchase of said trash and
recycling toters to be in its best interest;

SECTION 4: Therefore, the Village Administrator is authorized to sign all necessary
documents, and to pay for the purchase of the trash and recycling toters attached as
Exhibit A;

SECTION 5: This Resolution shall take effect and be in force from and after
the earliest period allowed by law.
