The following is the School Resource Officer Report for April 2019.

On Wednesday, April 3, District IT Director Eric Griffith and I attended a seminar hosted by Integrated Protection Services in Cincinnati. During the seminar we viewed multiple products of various types that we could employ to increase the productivity of existing safety systems at Covington Schools.

On Tuesday, April 9, Miami County Safe Communities Coalition held their annual Seat Belt Challenge at Covington High School. We had a 92% compliance rating, with only one student driver found to not be wearing their seatbelt. The overwhelming majority of those not wearing seatbelts were in vehicles being driven by parents.

On Wednesday, April 10, Chief Lee Harmon and I assisted the Miami County Safe Communities Coalition with the Seat Belt Challenge at Bradford High School, which had an 87.1% compliance rating.

On Monday, April 15, I assisted athletic staff with the Junior High Quad-Track Meet.

On Wednesday and Thursday, April 24 and 25, Chief Lee Harmon, Officer Steve Blei and I attended the annual Miami County Victim Witness Seminar, this year's focus was on Stalking and Domestic Abuse.

On Friday, April 26, the Covington Fire Department and I hosted the Juniors and Seniors at the Fire Department for a Pre-Prom Activity. The Fire Department speaks with the students on fire safety and I speak to the students on substance abuse and had them complete tasks while wearing "drunk goggles."

Saturday, April 27 was the Covington High School Prom at Stillwater Valley Golf Course. I attended both Prom and After-Prom, which was held at Covington High School. The night was a success with no issues.

Finally, on Tuesday, April 30, I assisted athletic staff with the annual Junior High Track Invitational with 12 total teams competing. The bad weather held off to have a dry meet.
