The following is the School Resource Officer Report for August 2017.

The 2017-2018 School Year began with some changes in the school administration. We have a new Junior High/High School Principal Jo DeMotte and new Athletic Director/Transportation Director Ashley Johnson. To begin the year, we have had many meetings with school administration and village officials as well to discuss if the School Resource Officer Program is meeting the expectations of the School District.

On Tuesday, August 15, I assisted High School Guidance Counselor Karen Brackman and Junior High Guidance Counselor Jim Meyer with student schedule pick-up. This gave me the ability to interact with our students and many parents as well. Wednesday, August 16, I met with Ms. DeMotte regarding the Emergency Operations Plan for the district to help her familiarize herself with the plan. I also met with Miss Johnson regarding the parking and security at the upcoming football games.

On Saturday, August 19, I attended and event at Fields of Grace that was focused towards "Back to School." During the event I talked with the kids regarding safety when going to and from school, as well as how to be safe at school.

Monday, August 21, was District-Wide meetings for all staff. I also met with the new staff members regarding the A.L.I.C.E. Emergency Protocols for Active Intruder Events. That evening was the District-Wide Open House that was very well attended across all grade levels. This gave me the opportunity to interact with students and their parents.

On Tuesday, August 22, was the first day of school for all students. We continued the same traffic pattern for pickup and drop off and had no issues.

The largest, and very alarming, issue is we had four vehicles pass school busses that were stopped with their red lights on and stop sign extended in the first four days of school. Thanks to the onboard cameras we were able to identify two of the vehicles and drivers by their license plates. Of those two, one was turned over to the Ohio State Highway Patrol due to its location of the violation and the other was identified as a Covington High School student and that was handled by school administration. The other two vehicles were unable to be identified, one had no front license plate and the other, the camera had a malfunction. Thankfully, our bus drivers are well trained and follow their safety procedures and because of this, none of our children were allowed off the bus, so were not in any danger.
