To Chief Lee Harmon:

The following is the School Resource Officer Activity Report for August 2018.

The 2018-2019 School Year officially began on August 21, which is the Fourth Year for the Full-Time School Resource Officer position at Covington. The month of August brought numerous meetings to discuss updated Emergency Operations Plans as well as new programs at the schools.

On Wednesday, August 1, I taught a 2 hour block on emergency responses in school buses to the district's bus drivers. Topics covered included: medical emergencies, traffic accidents, fights, armed attackers, bomb threats and fires. Then in the afternoon, our School Nurse and I re-certified them in CPR/First Aid through American Heart Association.

On Tuesday, August 7, Chief Harmon and I participated in the Dick Minnich Golf Scramble, the funds raised in this event help with scholarships for Covington Students.

On Tuesday, August 14, I spent the day with both High School and Junior High Guidance Counselors for student schedule pick up. This is a great way to get in touch with students and parents prior to the start of school.

On Friday, August 17, Chief Harmon and I did an ALICE armed intruder training refresher for all Covington Schools staff. This training lasted about four hours, and was a mix of both classroom presentation and hands on activities.

Monday, August 20, was the Covington Schools open house. I assisted with handing out Chromebook computers to our high school students. This activity helps me interact with a large group of our students and be visible to other students and their parents.

Friday, August 25, was our first home Football Game of the season against St. Henry. There have been a few minor changes to the game day experience, but I continue to work closely with the Athletic Director and School Administration to ensure that we provide a safe and secure environment at all games.

On Friday, August 31, I escorted our 3<sup>rd</sup> Graders on their annual walking field trip to historic sites around town and then to Ft. Rowdy in the Park. I helped with blocking intersections so that the staff and students could safely cross the streets to get to their destinations. It was a hot day, but the students enjoyed the trip.

As with my three previous years, the day to day duties in the schools continue with little change. Daily activities include: parking lot checks, building walk-throughs, exterior door checks, assisting in the cafeterias as needed with supervision (statistically this is where fights or other incidents may occur), attendance issues, as well as any other issue that arises during the day.
