The following is the School Resource Officer Report for December 2018.

On Thursday, December 6, the annual Covington Elementary School Christmas Play was held in the Elementary Gym. This year was one of the largest crowds in attendance in my four years as the SRO. I assisted with parking and traffic flow before and after the event.

Starting last month, the various agencies that have School Resource Officers decided to begin holding a monthly meeting to get all of our SRO's in one room to discuss various issues. This month's meeting was December 12. The agencies with representatives there in addition to the Covington Police Department are: Miami County Sheriff's Office, Troy Police Department, Piqua Police Department, Tipp City Police Department, and Huber Heights Police Department. Some topics discussed were: summer programs, bullying, substance abuse, teen depression, as well as various other school related topics.

On December 14, I was invited into Mr. Tobias's High School Health Class to speak on Opioid Abuse. During the presentations, I spoke on decision making, what makes opioids a popular drug choice, and the effects of drugs on the individual's life. This presentation is an adaptation from the Health and Opioid Prevention Education (HOPE) Curriculum that we implemented last year.

The winter sports season continued during December. This school year, in addition to having two officers at every High School Boys Basketball game, we are providing one officer at each High School Girls Basketball game as well. This was at the request of the school due to issues in previous years with various fans. During December, I worked the following games: Dec 1 Girls vs. Versailles and Boys vs. Milton-Union, Dec 3 Girls vs. Twin Valley South, Dec 7 Boys vs. Mississinawa Valley, Dec 18 Boys vs. Bradford. I also travelled to Franklin Monroe on Dec 14 to support our student athletes there during the Boys basketball game.

Also new this year was the first annual Covington Buccaneer Holiday Classic Basketball Tournament on Dec. 28 and 29. This Tournament consisted of Boys and Girls Junior Varsity and Varsity Teams from Covington, Newton, Milton-Union and Graham, Northwestern Girls Junior Varsity stepped in for Milton-Union who was unable to field a team at that level this year. Covington Girls won the Girls Championship and Graham Boys won the Boys Championship. During the tournament, I was assisted by Officer Aaron Zuhl who worked both days with me. Each day we did have to escort a fan from the school at the request of the game officials.
