The following is the School Resource Officer Report for February 2019.

February was a busy month with many sporting events as the winter sports seasons come to a close, bad weather, and numerous student behavioral issues inside of the schools.

On Thursday, February 7, I attended the Miami County Safe Communities Meeting in Troy. During this meeting, upcoming events were discussed, such as the County-Wide Seatbelt Challenge, Prom events, and Summer Programing for kids, such as Safety Town.

On Tuesday, February 12, Miami East's SRO Deputy Roger Davidson of the Miami County Sheriff's Office and I met with the Covington Elementary PTO in regards to Safety Town that the Sheriff's Office is hosting this summer.

There were many sporting events this month, games I worked or attended include: 02/01 Bethel (Boys), 02/02 Northwestern (Boys), 02/04 Ansonia (Girls), 02/08 Tri-Village (Boys), 02/11 Troy (Girls), 02/12 Lehman Catholic (Boys), 02/16 Tournament vs. TCN (Girls), and 02/27 Tournament vs. FM (Girls). In addition to the Covington Games, Covington High School also hosted a Division 3 Girls Basketball Tournament on seven days, which I worked three. Then on 02/22 and 02/23 Covington High School hosted a Wrestling Sectional Tournament which I worked both days of the event.

During February, we had two fights in the building, one between high school students on a bus and the other between junior high students in "The Corridor." These charges are the same that have been issued against all students who fight on school owned property and in all cases School Discipline is issued by the appropriate administrator.
