The following is the January 2017 SRO Activity Report:

January is a slow month for the school, as the 2<sup>nd</sup> Academic Quarter ends in the first part of the month following Christmas Break, and the 3<sup>rd</sup> Quarter begins. We also had two Snow Days during the month. I was also out of district for Court three days during the month. There were no classroom presentations due to the beginning of the new quarter.

My daily activities continue to evolve over the school year as needs are found with the new facility. In addition to the daily building walk-throughs and parking lot checks, I assist with lunch observation for nearly all 13 grades that eat in our cafeteria. This is a crucial time that has been identified not only by School Administrators, but by studying school violence reports as the most common time for violence to occur in the buildings. In addition to these activities, I also remain visible during the High School and Junior High class changes.

We continue the busy Winter Sports Season, working 4 Home High School Boys Basketball Games against Milton-Union, Tri-County North, National Trail and Bethel. The first three games had no issues, however we had a couple issues with the crowd during the Bethel game, resulting in one fan being removed from the school for using inappropriate and offensive language. This is the first time in my two years of being the SRO that we have had to remove a fan from any sporting event.
