The following is the School Resource Officer Report for March 2018.

On Monday, March 5, I met with our bus drivers to discuss safety related questions that the drivers had. We are also planning a training for our drivers that will be more detailed during the summer. On Friday, March 23, I spoke to Mr. Pond's Health Class. This continued our education of our 7<sup>th</sup> Graders in our HOPE Curriculum focusing on drug use prevention and making positive decisions.

This month saw the first true bullying case arise in my three school years as the School Resource Officer. The situation took place in the High School between a male and female student who had dated earlier in the school year. The bullying took place in person as well as on social media, and caused significant emotional distress to the female victim. Due to the amount of incidents and the severity, the male student was charged in Miami County Juvenile Court with Menacing by Stalking, which contains Ohio's bullying, as well as school based discipline. In addition to this case, the school administrators and I investigated two other possible bullying incidents that were both unfounded.

We also had three more reports of vehicles passing a stopped school bus that had its red lights and stop sign activated. Two of the vehicles we were unable to identify due to snow on the camera on one and the other had an obscured front license plate. The last incident is one of the most egregious acts of reckless driving and passing a stopped school bus. The offending vehicle passed the bus from behind while the bus was stopped to pick up a special needs student. Thankfully, the student and her mother were on the door side of the bus, and did not have to cross the road, or else the violation could have been much worse. Thanks to our on board camera system on the buses, we were able to identify the vehicle. I made contact with the registered owner, who admitted to passing the bus. She was charged with Reckless Operation and Passing a Stopped School Bus.
