The following is the Covington School Resource Officer Report for November 2019.

November was a quick and quiet month in the school district, but we did have a few events this month:

On Thursday, November 7, the Covington High School FFA held their annual Veteran's Day Assembly. This event continues to grow in the number of veterans in attendance.

On Monday and Tuesday, November 18 and 19, I attended a training at the Columbus Police Department's Police Academy. While I was away from the school, Officer A.J. Hickman worked in the school to further his training for taking over the School Resource Officer position in the coming months.
