On November 5<sup>th</sup>, I had a great opportunity to interact with the kids in Mrs. Dunn's eighth grade STEM class. The kids were given materials to make a kite and we flew them outside in the Elementary School parking lot. It was a great opportunity for me to have fun and interact with the students.

On November 6<sup>th</sup>, I spoke with Mrs. Crawford for a paper that she was working on for schooling that had to deal with Over the Counter Drugs. She asked me a series of questions related to juveniles using OTC drugs and my experience with people abusing them.
