To Chief Lee Harmon:

The following is the School Resource Officer Report for October 2017.

October was the month of special events in addition to my normal daily activities. The special events include classroom presentations, sporting events and Halloween related events.

On Friday, October 6, Covington Schools completed their first State Required Lockdown Drill of this school year. We have many options when it comes to Lockdown Drills. The main options are: Lockdown-External Threat: during this Lockdown students and staff go about their normal day, however nobody is allowed outside of the building. This would be used in the event of police activity near the school or even an airborne hazard, such as a fire or hazardous materials incident nearby. Lockdown-Medical Emergency/Other-Emergency not requiring evacuation: During this Lockdown, students and staff are required to be inside their locked classrooms, may not be outside the building or in the hallways. This is our most commonly used Lockdown as it is used anytime Emergency Medical Services are called to the building. The final option is "Initiate A.L.I.C.E." this is used for an immediate threat inside the building such as an "active shooter." During this event, the primary goal of staff and students is to get out of the building to safety. For the Drill on October 6, we chose to practice the "Lockdown-Medical Emergency" option, interestingly enough, we had to place Covington High School into the "Lockdown-Medical Emergency" for an actual situation just 7 school days after our drill.

Monday, October 9 was the beginning of "Fire Prevention Week" and Covington Fire and Rescue hosted the Firefighter Phil program again this year for Covington Elementary Students. During this program the students are taught about fire safety through the use of humor, magic and ventriloquism. While this was not my first year attending the program, it was my first year attending as not only the SRO, but also as a Firefighter/EMT for Covington Fire and Rescue as I began working there this past April.

On Tuesday, Wednesday and Thursday, October 17, 18, 19, Covington Elementary Guidance Counselor Jim Meyer and I went to each of the three Fifth Grade classes and talked to the students about Bullying. Each student then completed an anonymous survey that had questions regarding bullying that they have witnessed, experiences or even participated in. This data will help the school address the exact type of bullying that the students feel occurs here at Covington Elementary.

Saturday, October 21, was the annual Fields of Grace: Trunk or Treat held in the Covington Community Park. This event is always very well attended. This year not only did I help pass out candy to the children, and a few adults, in attendance, I was asked to help judge in the Trunk Decorating Contest.

On Wednesday, October 25, I visited the entire Sixth Grade Class at Covington Elementary and gave a presentation on Bullying. During this presentation, we discuss what bullying is, ways to report it, ways to prevent it and what to do if you are a victim.

Thursday, October 26, was the annual Covington Noon Optimist Costume Contest held on Wright St. This year we had around 100 people in attendance with 27 costumes judged. We continue to try to encourage more of our students to participate in the event.



Friday, October 27, was the annual Miami County Sex Offender Address Verification "Round-Up." During this event, officers and deputies from every law enforcement agency are split up into multiple 4 person teams. Each team is assigned a group of Sex Offenders and they then visit every Offender on the Registry to verify that they are in fact living where they are registered at.

On Saturday, October 28, Officer Kevin Wright and I attended the Miami County Park District's Trunk or Treat at Lost Creek Park east of Troy. This is my second year attending, and while the crowd was significantly less than last year, all who attended had a great time.

Finally, on Tuesday, October 31, was the Village of Covington's Trick or Treat Night. This year's crowd was large to begin the event, but with the cold temperatures, the crowd thinned out after about an hour. This best thing of the night was the fact that we had another year with no incidents during the event.

This month also had the end of the 2017 Football Season. We had two home games during October, Friday, October 6 and Friday October 20. The only issue we had this football season was on the last home game, the visiting school's buses decided to drive across our practice field causing some damage to that field. This issue is being handled between the two districts superintendents.
