The following is the Covington School Resource Officer Report for September 2020.

On September 8 and 9, I was in charge of passing out parking passes to our Junior and Senior students who drive to school and park in student parking on school grounds. For students to be able to park at school they must have a parking pass and park in their assigned spot. All parking spots are numbered so we can identify who is involved if an issue occurs. All students need to do to be issued a parking pass is to fill out there information such as vehicle, insurance, and have their parents sign the form.
