The following is the Covington School Resource Officer Report for April 2022.

During the month of April there were several positive things going on at the school that I was involved in with our students and staff.

On April 11, I taught hunter safety to our Ag. Students. The class was taught to all high school Ag. Students over four different class periods. In the class students were taught the proper way to handle a firearm while hunting. They were taught the proper clothing that needed to be worn that is state law during a firearms season. Students were given the opportunity to handle fake shotguns, rifles, and pistols. During this presentation students were taught how to be safe with these types of firearms and how to treat them through the four rules of firearm safety.

On April 22, I was able to lead a group at the Stillwater prairie for the "Bucks in the Wild" event hosted by the FFA students. This event was for second and third grade students. The activities at this event consisted of a scavenger hunt, hiking, fishing which is the activity that I was in charge of, and many other outdoor activities. This event took place for earth day. While leading the fishing activities I believe that our students caught approximately fifteen to twenty fish for the day. I was able to have a great time with the second and third grade students doing this and I hope to be able to do it again in the future.

On April 27, the school hosted its bi-annual mock crash. The mock crash consisted of members from the Covington Police Department, Covington Fire and Rescue, Care Flight, Stocker Fraley Funeral Home, and Dick Lumpkins Towing. This event took place just a few days before prom to demonstrate to the high school students what can happen from drunk or distracted driving. I would like to thank Mrs. Iddings for organizing the event. The event went well and I look forward to doing it again in two years.
