Project Updates

- **Wastewater Treatment Plant Project** – The Village approved the new Wastewater Treatment Plant by Resolution R07-23 and R08-23. The plant will be built by Peterson Construction over the next 18 months, with an estimated completion date of Fall, 2024.
- **Government Center Design** – The Village is working with Garmann / Miller to update and design the Government Center. This will include a remodel for the administration and police areas of the building along with the construction of a new Council Chambers. The design is estimated to be completed in July.
- **High Street Project** – The lights have been installed! The decorative bases are still on back order but will be installed once they are delivered. This project has been a very long process, but our downtown looks better than ever. We look forward to getting some additional planters out this Spring / Summer to make the downtown look amazing!
- **Sellman’s Warehouse Project** – The Village purchased the old Sellman’s Warehouses on the corner of Main Street and Wright Street. In working with Jane Sellman, the Village acquired the properties to work with the community to find the best use for the property in the future. The Village is working to develop a plan and will be reaching out to the community to discuss this further.
