#### Mayor's Report

# Water Plant Filter Media Replacement Project

A&N Construction has completed the blasting and refinishing the inside of Filter #2 and will begin reinstalling the filter media and putting Filter #3 back together. We should have it back on-line by Friday of next week and start working on Filter #1 on 8/17/20. Our project engineer Mote & Associates advised us that they feel this tank and tank #3 were not properly prepped before the original coatings were installed when the tanks were new.

# **Fire/EMS Levy Renewal**

The renewal paperwork for the existing 2.5 mill levy for the purpose of providing and maintaining Fire and EMS services and related expenses has been filed with the Board of Elections. This is a straight renewal and is not an increase in millage.

# **Sweet Treat Water and Sewer Taps**

The water and sewer taps for Sweet Treats have been installed and digging for the footers is planned for later this week.

# **CARES Act Funds**

\$80,585.18 has been received as Covington's share of the CARES Act funds. Requesting Council waive the three-reading rule on Ordinance 12-20 amending the 2020 budget. This ordinance amends appropriations by increasing the appropriations for the Coronavirus fund (11) from \$0 to \$80,585.18 and is necessary to allow for previously unbudgeted, unaccounted for and unforeseen expenditures specifically due to the public health emergency caused by the Coronavirus Disease 2019. (COVID-19)

# Sale of the vacant lot located at 110 N. Pearl Street

Recommending Council have first reading on Resolution R29-20 authorizing the Village Administrator to sell Parcel H19-001440 also known as 110 N. Pearl Street to the Newberry Preservation Foundation, an Ohio not-for-profit corporation. The sale price will be \$20,000.00. This sale and proposed use of the property is consistent with the previously approved Downtown Redevelopment District (DRD).
