Mayor's Report

Village Administrator Report – the following topics were addressed:

2020 Sidewalk Program

The assessments will be advertised in the paper this week. Council will need to pass a resolution at the next council meeting authorizing the fiscal officer to file the assessments. The assessment spreadsheet is included in council's packet.

Water Plant Filter Media Replacement Project

A&N Construction has cleaned out Filter #1. The media inside this filter was mixed and somewhat solidified, and had to be broken up to remove it. Our project engineer, Mote and Associates, is recommending we blast and recoat this filter as well.

The upside is that we are already seeing an increase in water quality from these filters.

Sweet Treat Water and Sewer Taps

The foundation is in for the Sweet Treats building, and they plan to install the water and sewer lines later this week.

Sale of the vacant lot located at 110 N. Pearl Street

Recommending Council have second reading on Resolution R29-20 authorizing the Village Administrator to sell Parcel H19-001440 also known as 110 N. Pearl Street to the Newberry Preservation Foundation, an Ohio not-for-profit corporation. The sale price will be \$20,000.00. This sale and proposed use of the property is consistent with the previously approved Downtown Redevelopment District (DRD).

Street Light Assessments

Requesting Council waive the three-reading rule and vote to approve Resolution R30-20 levying special street lighting assessments in the amount of \$45,000 for 2021, which is the same as previous years and is not an increase.

Included in Council's packet is the invoice for streetlight changeouts in the amount of \$17,780.00. Requesting Council vote to approve payment of this invoice at tonight's meeting.

OPWC Application for High Street

Requesting Council waive the three-reading rule and vote to approve Resolution R31-20 authorizing the Mayor to prepare and submit an application to participate in the OPWC capital improvement and/or local transportation improvement program(s) and execute contracts as required. This is for the High Street Improvement Project.

Miami County Budget Commission Tax Rates

Requesting Council vote to accept the Rates of Tax as determined by the Miami County Budget Commission for the year 2020. These rates are in Council's packet.

All ayes. Motion carried.

Motion to approve Resolution R31-20 was made by Tobias and seconded by Warner. All ayes. Motion carried.

Motion to approve the rates of tax as determined by the Miami County Budget Commission for the year 2020 was made by Tobias and seconded by Warner. All ayes. Motion carried.

Motion to approve the pay request from Miami Valley Lighting for the 2020 street light upgrade project in the amount of \$17,780.00 was made by Tobias and seconded by Newman. All ayes. Motion carried.

Motion to accept the resignation of Michael Busse as Village Administrator effective @ 5:00 PM on September 11, 2020 was made by Tobias and seconded by Reynolds. Weer, Warner, Duff, Tobias and Reynolds voted aye. Newman voted no. Motion carried.
