Village Administrator Report – the following topics were addressed:

Downtown Redevelopment Fund

Requesting Council vote on Ordinance 19-19 establishing a Downtown Redevelopment Fund. The proposed effective date is January 1, 2020.

Miami Valley Lighting

Recommending Council vote to approve Resolution R26-19 authorizing the Village Administrator to enter into a multi-year contract with Miami Valley Lighting for street lighting which includes upgrading all lighting provided under contract to LED lights.

Basketball Court Renovations

Requesting Council approve pay request #2 in the amount of \$85,768.30 to Brumbaugh Construction.

Casey's Project

The building exterior is up and work is continuing inside. Site work is continuing as the weather allows.

Marias Project

The teardown of the existing buildings is underway. Crews are removing items from the buildings and are working to disconnect utilities. The buildings will be torn down and the site cleaned up over the next few weeks.

Zoning Activity

The Board of Appeals will meet on Monday, December 9, 2019 @ 6:00 PM to review an application for variance by the Covington Board of Education for an on-premise sign.

Requesting Council waive the three-reading rule and vote to approve Ordinance 23-19 approving Planning and Zonings recommendations to replat inlots 475 and 476 combining them into one lot.

Water Plant

Chemical feed room renovations have begun with an anticipated completion in February 2020.

Donations

Motion to accept a \$15,000 donation from the Covington Community Chest to purchase police department bulletproof vests was made by Warner and seconded by Duff. All ayes. Motion carried.

Motion to waive the three-reading rule and vote on Ordinance 23-19 approving the replat of inlots 475 and 476 was made by Tobias and seconded by Weer. All ayes. Motion carried.

Motion to approve Ordinance 23-19 was made by Tobas and seconded by Smith. All ayes. Motion carried.
