Village Administrator Report-the following topics were addressed:

Sewer Plant Renovations

The hand railing contractor will be out tomorrow to measure for the hand rails. Work is continuing on the electrical. As soon as the weather is fit, Jutte will finish the painting of the pipes inside the valve vault and pump pit. The pumps have been delivered and will be installed as soon as the painting is completed.

CH2MHill has submitted an invoice for a progress payment in the amount of \$44,585.67.

2018 Budget

Included in Council's packet is the revised budget for year ending December 31, 2018. Mr. Busse modified the proposed budget to include funding for the purchase of real estate if Council chooses to move forward with the purchase

2018 Sidewalk Program

The 2018 sidewalk program bid on March 2, 2018 at 10:00 AM. The apparent low bidder was M&T Excavating. Requesting Council accept the bid provided by M&T, and pass Resolution R6-18 authorizing the Village Administrator to award the bid. If Council approves the awarding of the bid, letters will be sent to property owners later this week.

Acquisition of Property

Requesting Council waive the three-reading rule and approve Ordinance 5-18 authorizing the Village Administrator to purchase 184 and 188 North High Street in Covington. The purchase amount will be \$75,000. These properties are both doubles.

137 N. High Street

Monnin Excavating is requesting a progress payment of \$3,427.50 for the asbestos removal at 137 N. High Street. The Miami County Health Department was also invoiced the same amount, and will pay Monnin Excavating directly for their half of the project. Weather permitting, this project with the exception of seeding, should be completed by the end of the week.
